2025 decals expire after December 31, 2025. If you are not able to renew your decal before the end of the year, the city offers a grace period until January 31, 2026.

INSPECTIONS: If this is your first time registering your golf cart or you recently purchased a new golf cart, you are required to have it inspected and pay the initial registration fee of \$40. **Prior to registration**, please bring your golf cart, driver's license, golf cart registration form and proof of insurance to the Flagler Beach Police Department located at 204 S. Flagler Ave.

INSPECTION TIMES: MONDAY - FRIDAY 8 AM – 6 PM *NO APPOINTMENT NEEDED*

REGISTRATION: Initial registration fee is \$40.00. Renewal fee is \$30.00. If you have not renewed your registration by January 31, 2026 the fee for renewal will be \$40.00.
